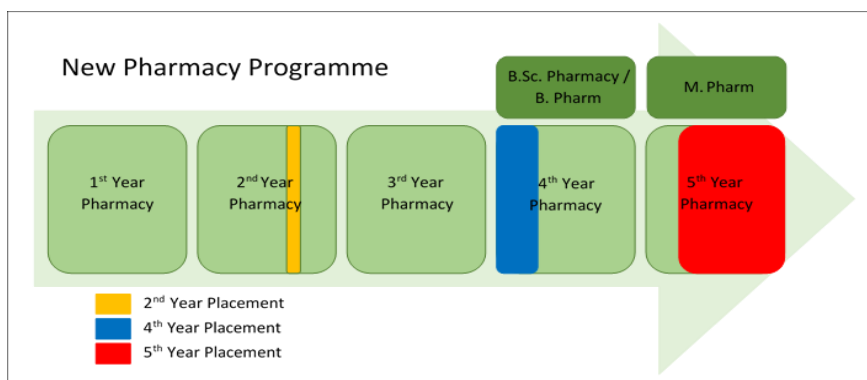

An Updated Model of Pharmacy Education

A new model of pharmacy education was introduced in September 2015. Pharmacy graduates now undertake a fully integrated programme which includes placements in a breadth of practice settings interspersed through the five years of their education.

This early practical and dispersed experience helps students to contextualise the theory they learn in their School of Pharmacy. Experiential learning throughout the integrated pharmacy programme provides students with the skills necessary to meet the demands of the future healthcare environment. Practice placements in hospital pharmacies will support students to develop the clinical skills and behaviours required to provide optimal patient care in accordance with evolving pharmacy practice.



Placement	Duration	Setting
2 nd -Year	2 weeks placement	Hospital or community pharmacy setting
4 th -Year	4 month placement (Sept – Dec)	All pharmacy practice settings
5 th -Year	8 month placement (Jan – Aug)	Hospital or community pharmacy setting

What is APPEL?

APPEL (Affiliation for Pharmacy Practice Experiential Learning) is a unique collaboration between University College Cork (UCC), the Royal College of Surgeons in Ireland (RCSI) and Trinity College Dublin (Trinity).

It was established to manage, centralise and streamline the experiential learning placements of the three Schools of Pharmacy in Ireland.

APPEL offers placement providers and students with a single point of contact and a source of expertise in relation to pharmacy placements.



Hospital Pharmacy Placements

How does the programme work?

Students undertake practice placements during the 5 year programme. These placements involve a mix of guided academic modules and authentic learning experiences guided by a Trainer while they attend placement.



What opportunities does the APPEL programme provide to pharmacists?

Training a student offers excellent CPD opportunities, peer-networking at APPEL events, opportunities for learning through teaching and learning from students, and opportunities to develop core competencies including leadership skills and human resources management skills.

In 2019, **89%** of all Preceptors said they would recommend acting as a Preceptor to other pharmacists and **93%** found it a rewarding and enjoyable experience. Feedback included;

Placement providers have a unique opportunity to increase awareness of their organisations in the Schools of Pharmacy and create an employment pipeline among pharmacy graduates. While they are on placement, students can become useful members of the pharmacy team as they engage with the prescription journey, participate in medicine stock management and help with dispensary tasks.

What does training an APPEL student entail?

Any qualified pharmacist can act as a Supervisor for a 2nd-Year student or as a Preceptor to a 4th-Year student but to act as a Senior Preceptor for a 5th-Year student you should have at least 3 years of post-registration experience

Supervision responsibilities differ based on which year the student is in;

- 2nd-Year: Supervise student while they attend placement, sign Supervisor's Report confirming student's on-placement attendance and achievement of certain learning outcomes.
- 4th & 5th-Year: Supervise student while they attend placement and complete two Competency Assessments to evaluate their ability to demonstrate behaviours from PSI's Core Competency Framework.

How does the matching process work?

For the short 2nd-Year Placements, students are assigned based on location. For 4th and 5th-Year the following steps take place:

Step 1: Placement Provider declares interest in taking an APPEL student for a placement.

Step 2: Placement provider enters the APPEL online matching system where they complete a brief description of what the placement will entail for the student.

Step 3: Students and Placement Providers are matched via the online system, given time to engage with each other and then can confirm the match online.

Step 4: Once the placement is confirmed, a Trainer is nominated. Training and accreditation documents need to be completed.



Training and Accreditation

In order to be recognised as an APPEL Trainer there is a requirement to complete Trainer Training. This can be done online at any time via www.appel.ie or at one of the APPEL organised face-to-face sessions.

In addition to this there is some documentation required to be completed. These documents include undertaking to follow the APPEL guidelines and ensuring that your Training Establishment will meet necessary standards
