# Infection Prevention & Control Training Requirements for 4th-Year Students in Clinical Placements 2023

APPEL currently requires that all students participating in patient-facing clinical placements (community pharmacy or hospital pharmacy) undertake training in relation to infection prevention and control prior to commencing their placement. This is in keeping with the HSEs ongoing requirement that all Higher Education Institutions (HEI's) provide an assurance that all students on clinical placement in HSE facilities or HSE-funded facilities have given undertakings in relation to infection prevention and control requirements\*.

In advance of commencing your placement you will be required to fulfil the training requirements as outlined below. A Certificate of Completion for each required element should be provided to APPEL for governance purposes. You will also be required to complete an Infection & Prevention Control Student Undertaking/Declaration, which is an addendum to the Student Placement Agreement. For your convenience, the Student Undertaking/Declaration and the course certificates can be completed and uploaded to the APPEL VLE- See Appendix 1. These requirements must be fulfilled in advance of the dates outlined in Appendix 2.

The training requirements are as follows:

- 1. Complete the following online Infection Prevention and Control courses on <a href="https://www.hseland.ie">www.hseland.ie</a>:
  - 1. AMRIC Introduction to Infection Prevention and Control
  - 2. AMRIC Basics of Infection Prevention and Control
  - 3. AMRIC Standard and Transmission Based Precautions
  - 4. AMRIC Hand Hygiene
  - 5. Putting on and Taking off PPE in Acute Healthcare Settings
  - 6. Putting on and Taking off PPE in Community Healthcare Settings

Courses 2 – 6 will generate a certificate once completed. These certificates must be uploaded to the VLE as described in Appendix 1. Course 1 will not create a certificate; you will need to take a screenshot once you have watched the video and upload this screenshot in the same manner.

Please note: these courses must be completed annually. If you have completed one or more of these courses in the past, they will need to be renewed in 2023 in advance of your APPEL placement (please see Appendix 2 for timelines).



## Appendix 1: Guide to completing pre 4th-Year placement requirements on the APPEL Virtual Learning Environment (VLE)

#### **Instructions**

1. Access the VLE via the following link - <a href="https://vle.appel.ie/login/index.php">https://vle.appel.ie/login/index.php</a> and log in, as usual, using your EduGate login details.



2. Navigate to the course - 2023-Year 4 APPEL Student Placement Agreement via the following link (https://vle.appel.ie/course/view.php?id=207)







3. Open the link to the Student Placement Agreement, enter your details on the first page and read through each section.



- 4. On page 5, sign and date the form. You must read this document carefully, and if you have any questions, please contact APPEL or your Practice Educator.
- 5. To upload your HSE course certificates, access the second link, and the following page will be displayed:



- 6. To add your certificates, click on the 'Add Entry' button.
- 7. Once you have entered your name, HEI and email address, you can begin uploading each certificate or screenshot in the specified area. Click on the blue arrow in each section to open the menu and select the correct certificate. Certificates must be uploaded during the same login session, so please complete all courses and have the certificates and screenshot ready to upload.

NB: There is a specific area for each certificate – please ensure that you upload the correct certificate into each area.



- 8. Once you have uploaded all 6 documents, click on the green 'Save and View' button at the bottom of the page to ensure everything is correct.
